I am directed to convey that the following will be the terms and reference of the Board for development of Kissans:

- a) To monitor the utility of Government Schemes and expenditure made on the Welfare programmes of the farmers;
- b) To identify the latest technological developments from the Agriculture Universalities, ICAR, and KVKs and publicize them with the help of Department of Agriculture and allied sectors among the farmers;
- c) Ensuring smooth distribution of Kissan Credit Cards and Soil Health Cards among the farmers and resolving their problems with the help of Director Agriculture/Chief Agriculture Officer;
- d) To assist in the creation of market for the agriculture produce/link the Farmers to the marketing officers of agriculture, horticulture and allied sectors;
- e) To assist the agriculturists in creating self help groups to earn income from farming activities especially post harvest;
- f) The Board, in coordination with SKUAST (J)&(K), shall examine the existing cropping patterns and farming system and suggest a

rational land use policy including programmes for marginal lands, wastelands as well as for flood, drought-prone and water-lodged areas.

- g) The Board shall suggest an integrated cropping pattern and a synergy between agriculture and allied sectors.
- h) The Board shall review the current status of water use in agriculture, its performance and potential and make recommendations for a rational, efficient and sustainable
- i) Exploitation of ground, surface and rain water for enhanced agricultural productivity.
- j) The Board shall recommend measures for stepping up investment in agriculture and related activities and promoting public-private partnership in agricultural enterprises.
- k) The Board shall hold Kissan Melas/IECs in every District and Block of the State under Capex Budget Plan to be allotted by the Finance Department through Agriculture Production Department, in which the demonstration of modern agriculture equipments and technology should be made to make the farmers skilled to utilize the technology.
